**Local Authorities (Model Code of Conduct) Order 2007**

**Register of Members Interests – Cheshire East Borough Council**

(The notes to this form give general guidance, but are not necessarily comprehensive. Part I of Schedule 1 of the Local Authorities (Model Code of Conduct) Order 2007, as adopted by Cheshire East Council as its Local Code gives precise requirements).

**NOTE: Sensitive information** – paragraph 14 of the Code says:

“ 14. –(1)Where you consider that the information relating to any of your personal interests is sensitive information, and your authority’s monitoring officer agrees, you need not include that information when registering that interest, or, as the case may be, a change to that interest under paragraph 13.

(2) You must, within 28 days of becoming aware of any change of circumstances which means that information excluded under paragraph (1) is no longer sensitive information, notify your authority’s monitoring officer asking that the information be included in your authority’s register of members’ interests.

(3) In this Code, “sensitive information” means information whose availability for inspection by the public creates, or is likely to create, a serious risk that you or a person who lives with you may be subjected to violence or intimidation.” (eg employment in certain scientific research). If you believe you qualify under this paragraph then contact the Monitoring Officer.
